Annual Parents Meeting

I enclose for your information, a copy of the Governors Annual Report to Parents for the 2023-2024 academic year.

Under the School Standards and Organisation (Wales) Act 2013 (the Act) the governing body is no longer required to hold a meeting for the purpose of discussing the attached report.

However, under this legislation if a governing body receives a petition from parents of registered pupils at the school requesting a meeting a meeting will be held if the following conditions are met;

- The petition contains the signatures of ten percent of the parents registered pupils or thirty of the parents of registered pupils (whichever is the lower).
- The meeting must be for the purpose of discussing a matter relating to the school.
- Should a meeting be held there will be no more than three meetings held during the school year in which the petition is received.
- There are enough days remaining in the school year for the meeting to be held in line with the requirements of the Act.

Should a meeting be held it will be open to all parents of registered pupils at the school, the Headteacher and other persons invited by the governing body.

Community Focused Schools

A community-focused school is one that: 'provides a range of services and activities', often beyond the school day, to help meet the needs of its pupils, their families and the wider community. Across Wales many schools already provide some community services including adult education, study support, ICT facilities and community sports programmes'.

The development of community-focused schools is not just a short-term project or initiative, but a real opportunity for schools and communities to work together in new ways for the future benefit of children, young people and adults.

We continue to work with parents and families in the community of Glenboi to provide support and guidance. Our Family Liaison officer, Ms Sian Beasley, liaises with parents and provided any assistance required. We continue to collaborate with Darrenlas Primary school and together work closely with all the other primary schools in the cluster and Mountain Ash Comprehensive School.

Review of School Policies

The school has a large number of Policy documents covering both curriculum and non-subject areas. These documents are constantly reviewed/revised by staff/governors to incorporate changing trends and legislation. Further information is available by contacting the Headteacher during school time.

Additional Learning Needs

The School's Policy for the Assessment of and Provision for, pupils with additional learning needs is summarised as follows:

The school's policy for the identification, assessment and provision for pupils with additional learning needs is consistent with the requirements of the Additional Learning Needs Code for Wales (approved by the Senedd on 23rd March 2021) under section 4 of the Additional Learning Needs and Education Tribunal (Wales) Act 2018.

The school's Additional Learning Needs Co-ordinator (ALNCo) works closely with all other members of staff to ensure that individual educational plans are developed and implemented to meet the needs of pupils, appropriate to those who require them.

The ALNCo also liaises with all members of staff, to ensure that the progress of all pupils is regularly monitored and assessed and to ensure that each pupil reaches his or her potential.

During the academic year 2023/2024, 7 pupils were in receipt of an Individual Development Plan (IDP) in mainstream and 7 pupils within our SEBD setting.

Access for Disabled Pupils

The governing body is mindful of the requirements of the Disability Discrimination Act (DDA) 1995 and The Special Needs and Disability Act (SENDA) 2005 in drawing up the School Development Plan/Post Inspection Action Plan, and the day to day operation of the whole site.

The school is committed to ensuring that all pupils are able to participate in the school curriculum and (where they desire) in activities such as after school clubs, leisure/sporting events and educational visits. All aspects of accessibility, including access to written information are included in the planning process.

The Authority has in place an Accessibility Strategy and in line with this strategy has had an audit of the school site undertaken, as part of an Authority wide brief, to identify any potential barriers and (ultimately) improve the access to the school.

Fabric of the Building and provision of toilet facilities

The building is in a good state of repair. Over the past year general repairs and maintenance have been completed.

Throughout the summer, our Caretaker carried out a programme of repairs to ensure that the buildings and outdoor areas remained in excellent repair in readiness for our return to school.

During the summer term extensive work was carried out on the new Little Ferns building, adjacent to Glenboi. This caused substantial disruption to the school, restricting access to the school yard, halting our ability to open Big Bocs Bywd and is still not yet completed in full.

The provision of toilet facilities for pupils at the school is carefully monitored and all facilities are cleaned regularly.

Target Setting

Targets for the school are noted in the School Development Plan. Pupils no longer have targets but are measured on achievement of progression steps

Attendance Information

The overall school attendance was 91.9% for 2023/24, 0.9% above our target for the year. Attendance of all pupils is closely monitored

Admission/Transition Arrangements

The County Borough Council is the Admissions Authority for all schools (other than Church schools where the schools governing body is the admissions authority) within the Authority's boundary. The schools admission arrangements are, therefore, operated in line with the Authority's policy on school admissions which is contained in the publication Starting School book. The book is made available to parents at the point of their application for their child's admission to school. The contents of this book can also be accessed online on the Authority's website.

Pupils will usually remain in the school until they complete year six and then transfer to secondary school. This school is a feeder school for Mountain Ash Comprehensive School, however, pupils may apply to attend any secondary school they choose subject to compliance with the Authority's admissions policy.

School Leavers

12 pupils left in Summer 2023. 8 pupils moved to Mountain Ash comprehensive School, 1 pupil to Aberdare Community School and pupils leaving our SEBD class transferred to Ty Gwyn or Ysgol Bro Taf.

Sporting Aims and Achievements

Wherever possible the school takes part in many sporting activities throughout the year including football, rugby, netball and swimming. The governing body attaches great importance to providing great opportunities for children of all talents to play as team members, recognising the positive effects on behaviour and the school ethos that participation in sport creates.

After school Activities

Whenever possible we try to offer extra-curricular clubs. Some take place during lunchtime sessions while most are organised for after school. These have included Expressive Arts, Needlework, Board Games, Choir, Coding Club and Football.

Involvement of Parents

The Governing Body celebrates good relationships between parents and the school. Events previously organised by the FOG (Friends of Glenboi) have included Summer Fayre Macmillian Coffee Morning, Halloween Disco, Valentines Disco, Family bingo and Movie nights.

A huge thank you goes to the Parents association, who raise a great deal of money throughout the year. We regularly hold Curriculum afternoons, coffee mornings and community events in school.

Educational Activities outside the classroom

A wide range of educational visits have previously been organised for the children throughout the year.

Healthy Eating

In Accordance with the Appetite for Life initiative, promoting healthy eating and drinking in the school is an ongoing focus, and certificates are regularly awarded to children who make healthy choices. The school is currently working towards Phase 5 of the healthy schools awards scheme.
